FOR THE FISCAL YEAR BEGINNING JULY 1, 2020 AND ENDING JUNE 30, 2021

IT RESOLVED BY THE ASHEVILLE CITY BOARD OF EDUCATION:

Section 1- The following revenues are estimated to be available to the State Public School Fund – Fund 1. The following expenditure amounts are hereby appropriated at the purpose level for the operation of the school administrative unit in the State Public School Fund for the fiscal year beginning July 1, 2020 and ending June 30, 2021.

Section 7- The Superintendent and Finance Officer are hereby authorized to transfer appropriations within a purpose level within a fund as contained herein under the following conditions:

Amounts may be transferred within a purpose level within a fund with proper justification.

Amounts may not be transferred between funds.

C. Amounts may not be transferred between Local Current appropriation and Local Capital appropriation without the approval of the Board of Education.


D. Amounts transferred from the Contingency Fund to a specific line item not previously provided for in this resolution do not exceed Five Thousand Dollars (\$5,000) for any line item. Any such transfer shall be reported to the Board at its next regular meeting and recorded in the minutes.

E. Fund Balance may be needed to satisfy actual expenditures during the fiscal year. The allocation of fund balance appropriated in the Budget Resolution is anticipatory only. Fund Balance is accounted for on the district's balance sheet and is adjusted at the end of the fiscal year. The actual amount of Fund Balance allocated for each fund, if any, will be reflected in the annual audit report.

Section 8- Copies of the Budget Resolution shall be furnished immediately to the Superintendent and Finance Officer for direction in carrying out their duties.

Section 9- The Interim Budget adopted on June 30, 2020 is hereby rescinded.
